 - **New Applicant:** 30 hours pre-licensing education
 - **1st Renewal:** 45 hours continuing education
 - **2nd Renewal:** 24 hours continuing education
- 7. Form I-9 Tax Clearance – *Valid for 90 days (For new, renewal, and transfer).*
- 8. Police Clearance – *Valid for 30 days (For new, renewal, and transfer).*
- 9. License Terms and Fees:
 - **Original (New) Salesperson:** 2-year → \$100.00
 - **Renewal Salesperson:** 4-year → \$200.00
 - **Transfer:** → \$25.00
